GalaxSea shall not be responsible for any injuries, damages or losses caused to any traveler in connections with terrorist activities, social or labor unrest, mechanical or construction failures or difficulties, diseases, local laws, climatic conditions, abnormal conditions or developments, or any other actions, omissions, or conditions outside these Parties control. These Parties are not responsible for cancellation of any service/s and or refunds from any supplier or carrier that may cease operations.

Traveler is hereby warned of the above risks as well as possible travel industry bankruptcies and medical and climatic disruptions, and is advised to obtain appropriate insurance coverage against them. Traveler's retention of tickets, reservations, or bookings after issuance shall constitute consent to the above and an agreement on his/her part and is expected to convey the contents hereto to his/her travel companions or group members.

Cancellation Penalties/Fees:

After March 1, 2019	\$200 per person, plus any non-refundable services
After June 28, 2019	\$1000 per person, plus any non-refundable services
After August 1, 2019	50% of package total, per person, plus any non-refundable services
After September 1, 2019	75% of package total, per person, plus any non-refundable services
After September 28, 2019	Full Penalty
