

## Consumer Terms and Conditions

These parties, therefore, shall not be responsible for breach of contract or any intentional careless actions or omissions on part of such suppliers, which result in any loss, damage, delay, or injury to you or your companions or group members. Unless the term "guaranteed" is specifically stated in schedule, or handling of personal effects.***

***These parties shall not be responsible for any injuries, damages or losses caused to any traveler in connection with terrorist activities, social or labor unrest, mechanical or construction failures or difficulties, diseases, local laws, climatic conditions, abnormal conditions or developments, or any other actions, omissions, or conditions outside of their control. These parties are not responsible for cancellation of any service/s and or refunds from any supplier or carrier that may cease operations.***

***Traveler is hereby warned of the above risks as well as possible travel industry bankruptcies and medical and climatic disruptions, and is advised to obtain appropriate insurance coverage against them. Traveler's retention of tickets, reservations, or bookings after issuance shall constitute consent to the above and an agreement on his/her part and is expected to convey the contents hereto to his/her travel companions or group members.***

### **Cancellation Penalties/Fees:**

After July 1, 2024	\$50 per person, plus any non-refundable services
After October 1, 2024	\$300 per person, plus any non-refundable services
After November 1, 2024	50% of package total, per person, plus any non-refundable services
After December 1, 2024	75% of package total, per person, plus any non-refundable services
After January 1, 2025	Full Penalty
