These Parties, therefore, shall not be responsible for breach of contract or any intentional careless actions or omissions on part of such Travel Suppliers, which would result in any loss, damage, delay, or injury to you or your traveling companions or group members. Unless the term "guaranteed" is specifically stated in schedule, or handling of personal effects.

These Parties shall not be responsible for any injuries, damages or losses caused to any traveler in connection with terrorist activities, social or labor unrest, mechanical or construction failures or difficulties, diseases, pandemics, local laws, climatic conditions, abnormal conditions or developments, or any other actions, omissions, or conditions outside of their control. These parties are not responsible for cancellation of any service/s and or refunds from any supplier or carrier that may cease operations.

Traveler is hereby warned of the above risks, as well as the possible travel industry bankruptcies, medical, and climatic disruptions, and is advised to obtain the appropriate insurance coverage against these risks. Traveler's booking deposit, retention of tickets, reservations, or bookings made after receiving deposit shall constitute consent to the above and an agreement on his/her part and is expected to convey the contents hereto to his/her travel companions or group members.

### **Cancellation Penalties/Fees:**

<b>After Initial Deposit</b>	<b>\$500 per person, plus any non-refundable services</b>
<b>After 2<sup>nd</sup> Deposit</b>	<b>\$1000 per person, plus any non-refundable services</b>
<b>After Final Payment</b>	<b>50% of trip cost per person, plus any non-refundable services</b>
<b>After August 16th</b>	<b>80% of trip cost per person</b>
<b>After September 2<sup>nd</sup></b>	<b>Non-refundable / Full Penalty</b>
